The Centro Argentino de Arte Textil, **CAAT**, calls members and non-members to participate in the II Virtual Photography Salon with Textile Image and/or Intervention.

The admitted images will be included in an online catalog to be exhibited on a screen at our offices, available on our website www.caat.org.ar, and on social media.

GENERAL REGULATION

I.DATES

Virtual Opening: Friday 6 September 2024, at 18hs. at our **CAAT** offices (Viamonte 1728 2E, CABA).

Closure of the Salon: Friday 11 October, 2024.

Closure of the call/Reception of the material: Friday 16 August, 2024 at 23:59hs. Buenos Aires (GMT-3).

II.REQUIREMENTS AND CONDITIONS

- Unpublished or non-unpublished work not being exhibited in another **CAAT** salon.
- Up to two (2) works per artist or group of artists may be submitted.
- The accepted works, photographs, images with any technique intervention, and textile materials or photographs with textile images will be exhibited.
- If the work uses third-party photographs, the artist should have the corresponding owner's authorization for its use.
- Topic is free. All types of techniques and materials will be accepted, comprehending textile art.

III.GROUPS OF ARTISTS

Participation of groups of artists will be allowed, being partners or non **CAAT** partners.

Every group of artists shall designate a team leader, who will be responsible for interacting with the **CAAT** during the registration, selection, and award process.

IV. PRESENTATION PROCEDURE

The following items are required:

- Email
- Name and Last name (in the case of a group of artists, one of the team leader)
- Place of residence
- Cellular phone
- Title of the work
- Technique
- Size
- Materials
- Conceptual memory (maximum 400 characters including spaces).
- Photographies of works
 - 1) One photo of the complete work with a neutral background (the sideways of the work should be seen plus the neutral background) which will be shown in the catalog.
 - 2) One detail of the work, neutral background.
- Value of the work
- Receipt of payment with the participant's name and last name

V. ABOUT IMAGES

Images should be presented in JPG format with a quality of 300 DPI, the longest side of the photography should be of a minimum of 10 cm. and a maximum of 15 cm. NEUTRAL BACKGROUND.

The quality of the digital image is absolutely important to allow the jury evaluate the work with full efficiency as well as keep up with the catalog.

The photographs should not have names or texts above them, they should be professional.

IMPORTANT: the name of each photograph (the file names) should include the title and type of the work (if it's complete or a detail). For example.: **titleofthework_detail1.jpg**

Images that will not meet the requirements will not be accepted.

VI. NOT TO BE ACCEPTED

It is hereby announced to every participant for the calls of **Centro Argentino de Arte Textil** that the following will not be admitted:

- Works having been shown at this salon the previous years.
- Works without identification.
- Works without fulfilling the requirements.
- Plagiarism.
- Works with images not adjusted to the required forms.

VII.FEES FOR REGISTRATION

CAAT partners: equivalent amount to one and a half (1 y 1/2) social contribution, current at the time of inscription.

Non-members: an amount equivalent to three (3) social contribution, current at the time of inscription

- In the case most of the artists of the group (50%) are **CAAT** partners, the work/s will be charged the member's fee. In the case most of the artists are non-members or most of them non-members, the works will be charged as non-members.
- Fees are non-refundable.
- Visual Arts grade students all over the country, showing a student card, will get a 50% discount in the Salon and/or Exhibitions organized by the **CAAT**.

VIII.JURIES

Works will be selected by a certified jury chosen by the **CAAT** and decisions will be indisputable.

IX.AWARDS

Awarding will be done on-site. Two awards and mentions will be granted according to the criteria of the jury. (certificates granted by the **CAAT**).

X.SELECTION

The selected artists will be informed using social media or email. The images of the chosen works will be included in an online catalog available on our website and social media.
